Entries must be postmarked Sept. 1. Entries received after that date will be subject to a \$25 late charge and space availability.

Special Notes: All animals crossing state lines must have health certificates that meet the Oregon Department of Agriculture regulations. A copy of the Health Certificate must be given to clerk upon check in. No animals will be unloaded until inspected by an OFFF check-in team member. Animals must be sound, healthy and free of external parasites. The Oregon Flock & Fiber Festival (OFFF) reserves the right to require removal of any animal judged unhealthy.

Sheep must have the required ID to be compliant with the USDA Scrapie Eradication Program. **If you bring sheep for display only, you do not have to enter them in the box below, but all sheep must have the required USDA Scrapie ID tags and comply with festival rules (see the special note above).**
